The distributed computation and communication capabilities of QF have become an integral part of the trading web and constitute a likely field for the emergence of artificial intelligence on a par in many respects with that of humans. This talk will discuss the brief history of electronic trading and Quantitative Finance, discuss the current architectures of the worldwide trading web, and explore the potential role of high-frequency financial trading as a catalyst for the emergence of computational intelligence that not only is faster than human minds but also, physically, orders of magnitude larger (<i>i.e.</i>, spanning the entire planet).</p> |
